MDACS is planning to dispose of Waste/scrap an unserviceable material lying in the MDACS Godown No.4. The offers are therefore invited from the scrap dealers dealing in line. You are requested to quote your most attractive and highest offer for the sale of scrap material as shown in accompanying statement. The Quantity of the material shown in the said statement is tentatively worked out and the same is likely to be changed on physical verification. **The due date of opening of quotations is 27.03.2026**

**Terms and Conditions:**

- 1) The contract will be given to the responsive and successful scrap dealers.
- 2) The offer of highest will be considered for awarding the contract.
- 3) The delivery of the waste and scrap material will be given only after the same is physically counted.
- 4) The successful contractor will have to deploy his own labour for loading and unloading etc. purposes.
- 5) The successful contractor should make his own arrangement of transportation at his own cost.
- 6) The entire operation of packing, loading & unloading and transportation & weighing shall be carried out by the contractor with his own resources, within the period of **21 days** from the date of acceptance of Work Order.
- 7) The contractor shall keep the premises clean and tidy.
- 8) Levy of taxes if any will be the liability of scrap dealer.
- 9) Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission. The withdrawal of the offer before validity period will entail forfeiture of EMD.
- 10) The offers shall be given in the accompanying format.
- 11) The Scrap Dealers shall submit attested copies of following documents
  - a) GST Certificates
  - b) PAN Card
- 12) Each bidder shall submit only one quotation.
- 13) The dealer shall pay Earnest Money Deposit of Rs. 4,500/- in Demand Draft drawn in favour of Mumbai Districts AIDS Control Society, which should be paid one day prior to

the due date of opening. The Withdrawal of offer before the validity period shall entail forfeiture of EMD.

14) MDACS will evaluate and compare the offers determined to be substantially responsive i.e. which are

- a) Properly signed; and
- b) Conform to the terms and conditions

15) MDACS will award the contract to the bidder whose offer has been determined to be substantially responsive and who has offered the highest rate.

- a) Notwithstanding the above, the MDACS reserves the right to accept or reject any offers and to cancel the bidding process and reject all offers at any time prior to the award of contract
- b) The bidder whose bid is accepted will be notified of the award of contract by MDACS prior to expiration of the offer validity period. The terms of the accepted offer shall be incorporated in the Acceptance letter.

16) **Penalty:**

- a. For delay– ½ % per week or part thereof after the expiry of the work order period subject to maximum 10%.
- b. If the contractor personnel are found responsible for any theft, loss of material/articles and damages, he/she shall be liable to pay immediate payment in actual, equivalent to the value of the article theft/lost/damaged or replacements decided by the MDACS depending on the gravity of the act.
- c. If the contractor does not lift the e-waste on pre-decided day and time of delivery, he/she shall be liable to pay penalty Rs. 5,000/- for that day, without prejudice to other conditions.
- d. In case if the contractor fails to remove complete delivery of the good sold or part thereof within stipulated period he/they shall be liable to pay demurrage charges at 2% of the sale value of unremoved quantity per day. Notwithstanding the facilities given above, the MDACS reserves the right to forfeit the amount paid by the Purchaser without any further notice and goods will be resold as deemed fit to the MDACS.
- e. The contractor is responsible to complete Data Deactivation degaussing/ storage media destruction.

17) The successful contractor shall make the payment of Rs. 10,000/- in cash within 7 days from the receipt of this order. Rest of the payment if any shall be made by the contractor immediately after confirmation of total numbers of the items.
