5. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

6.1. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

6.2. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order

6. Payment shall be made within 30 days from the receipt of bill along with report of the delivery with stamp and signature of authorized person as acknowledgement.
7. As per prevailing rules TDS / SGST / CGST will deducted at source towards income tax / SGST / CGST from all the bills submitted to the department. The TDS / SGST / CGST certificate shall be generated on line by Finance section of Mumbai Districts AIDS Control Society.
8. Purchaser reserves the right at the time of contract award to increase or decrease the quantities indicated above by 25% without any change in the unit price or any other terms and conditions.
9. **The supplier should provide a 3 Years warranty that will include Comprehensive Annual Maintenance Contract (CAMC) including all spare parts and repairs.**
10. The quotation should be sealed with wax.
11. **Incomplete, irregular, unsealed, unsigned and Quotations received after the due date and time will not be considered.**
12. The Quotationers must fill up the rates in the format given along with the Quotations notice. The quotation must be stamp and signed by authorized person. **If it is filled up in any other format, the same shall be rejected outright.**
13. The Quotationers must submit the **EMD of Rs. 2,460/- by Demand Draft, Banker's cheque, Bank Guarantee from any bank or payment online in an acceptable form. The Demand Draft should be drawn in favor of Mumbai Districts AIDS Control Society.** The withdrawal of the offer before validity period will entail forfeiture of EMD. The EMD should be paid up to 03.00 p.m. one day prior to the opening of the Quotation. A copy the EMD Receipt should be kept should along with quotation. EMD Receipt no. should be mentioned on the Envelope.
14. Notwithstanding the above, the MDACS reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract without assigning any reason.
15. Copy of GST Certificate & PAN card should be submitted.
16. The Quotationers must paginate the quotation properly.
17. **Performance Security:**

The successful bidder will have to pay **5% as Security Deposit by Demand Draft, Banker's cheque or bank guarantee from any bank or payment online in on acceptable form only within 15 days on receipt of the purchase order.** If they fail to pay the Security Deposit within stipulated period, the contractor will be charged extra Rs. 100/- as a penalty.

Security Deposit will be refunded after two months from completion of satisfactory supply.

18. Penalty

- a. For delay supply – ½ % per week or part thereof after the expiry of the delivery period subject to maximum 10%.
- b. Failure of the supply – Earnest Money Deposit cum contract deposit will be forfeited and the material will be purchased at the risk and cost of the suppliers.
- c. Variation in specification – material will be rejected and cost of the said material will be recovered from the supplier.

19. Last Date and time of receipt of quotations:

The Quotationers must fill up the rates in the format given along with the Quotations notice. Quotationers should submit their sealed Quotation in sealed envelope sealed with sealing wax duly super-scribed on the envelope as "Quotation for procurement of centrifuge machines for ART & ICTC centers." due on 04 . 10 .2024 latest by 1.00 p.m. which will be opened on the due date at 3.00 p.m.

Centrifuge Specification

1. Speed regulator: Maximum speed required at least 4000rpm with increment of at least 100rpm
2. Safety Lid lock
3. Digital Speed meter
4. Timer of setting time between 0 to 60 min. with increment of at least 5 min
5. Rotor: Angled head with capacity for at least 3-8ml blood tubes fit
6. Adaptors Each with Capacity of 6ml tube & 8ml tube

Facility for level adjustment and firm base to prevent walking and provide assure stability while equipment is in use:

1. Electrical compatibility: Power plug should fit on Indian system of electrical supply.
2. Should be able to accommodate **08, 12 & 32 tubes.**
3. The product must be CE (European)/BIS approved

Other Conditions:

1. The supplier should provide a 3 Years warranty that will include Comprehensive Annual Maintenance Contract (CAMC) including all spare parts and repairs.
2. Equipment should be calibrated for 1 year as per ISO guideline.
3. The manufacturer should be able to provide service of equipment across India within 24hrs after receipt of breakdown report for the metro location and within 3 Days for the non-metro located instruments.
4. Purchaser reserves the right to subject the equipment for independent evaluation and performance.
5. The company will provide installation qualification, operational and performance qualification with log book for maintenance of the equipment at no extra cost.
6. Company will be responsible for training lab staff on operation of equipment.
7. Manuals: Operation, maintenance and part list with detailed specifications must be provided in original.
